MINUTES of the Ordinary Meeting held on Monday 13th February 2023 at 7.00pm in Boat of Garten Community Hall

1. Record of Attendees and Apologies Received:

2. Minutes of the Ordinary Meeting held on 28th November 2022:

3. Matters Arising:

There were no matters arising that were not on the agenda.

4. Declarations of Interest:

4.a Concerns arising regarding Drug Dependency

Muriel Cockburn advised that in a recent report, the demographic in the Highlands appears not to be the younger generation, but to be older peoples dependency on prescription medications.

5. Finance:

Alan Bennett presented the Treasurer's Report.

5.a Questions regarding funds put aside for the living Christmas Tree

Kathryn Gillings asked what happened regarding the living Christmas tree with rootball. Alan Bennet responded that with the closure of the sawmill, provision of the tree did not happen. However, he looked into an alternative source, but the cost was problematic at over £900.

5.b Remembrance Day wreaths

Kathryn Gillings asked about a repeat order for a Remembrance Day wreath, but Alan Bennet responded that it is only once a year and would not be economical as there is no saving.

5.c Christmas Lights

Alan Bennet spoke about previous unsuccessful attempts to improve the village Christmas Lights by fundraising.

Kathryn Gillings asked, since the Community Council pays for the Christmas Lights, do we know why they had been taken down so late in the evening, after 11pm. No answer was available.

6.a Short Term Lets

Multiple questions were raised regarding Short Term Holiday Lets in the village, in the light of recent applications, many of which are understood to be repeats. Why has the Highland Council allowed so many through? As yet there has been no formal explanation from HC.

Muriel Cockburn reported regarding possible opening of a new Hospital in Inverness in March 2023.

NHS Highlands Care at Home service is struggling.
