## 10a. Capercaillie/Dog walking project update

AB reported the positive news is that there are twice the number of capercaillie living in Deshar Woods as there were 4 years ago. These account for 2% of the capercaillie population in the HIghlands and consist of 13 males and a good number of hens. New signage is to go up in the woods from 1/4/24-3/8/24 asking walkers to be considerate of the nesting birds and dog owners to have dogs on short leads.

There had been concerns that new new estate at the top of the village, backing on to the nesting grounds, may have been detrimental to the capercaillie. The increase in bird numbers hopefully proves these fears to be unfounded.

Dog walking paths across the bonfire field have been proposed to alleviate possible problems.
