Draft Minutes of the Ordinary Meeting Monday 17th February 2025 in Boat of Garten Community Hall

1. Record of Attendees and Apologies Received:

2. Minutes of the Ordinary Meeting held on 9th December 2024:

The minutes were proposed as an accurate record of the meeting by DW, seconded by AB.

3. Matters Arising

3a. Village signs

DW has been unable to establish who is responsible for the signs. The Repair Cafe have said they would be willing to look at what could be done to improve the signs but want clarification of who is responsible for them first.

Jacquie Macintyre (JMac) had posed the same question in the most recent edition of The BOG Standard but JW and JM confirmed that as yet there has been no response from the public.

JW asked if the Community Company could apply for funding to improve the signs.

There was discussion of an email from CNPA re Visitor Infrastructure Improvement Programme-Development Phase Funding. This email was received after our last meeting in December and has a closing date of 31st January 2025. However, the email does state that "applications may be accepted after that subject to budgets."

Agreement that this may be of interest to the Community Company in terms of the village signs.

AB commented that this may emerge as an issue from the village 'Community Improvement Plan' consultation currently taking place.

AB reported that expenses such as insurance and payment to The Highland Council, for the festive lights, would be due soon.

7. Planning Matters

There were no planning matters requiring discussion.

8. Correspondence

8a. Ex-sawmill site

An update email was received from the company Totally Sustainability re the ex-sawmill site. In March 2024 they contacted the community council to outline their proposals for some sort of "Circular Economy Hub".

They report that when the selling of the site did go to a closing date in August 2024, they offered the ultimate owners, Binderholz, significant business benefits, in return for getting community access to the site rent free for 10 years. This bid was unsuccessful.

DW raised concerns re the poor state of the site, particularly given that it is within a national park. All agreed that the site is an eyesore and not a welcoming entry point to the village. MC felt that there was no excuse for the site not being tidied up and 'made presentable'. All agreed that it had a negative visual impact on the village.

DW voiced possible plans for CNPA to be based here with the addition of small business units, visitor centre, cafe, etc. All agreed that this could provide an opportunity to 'visit CNPA in the heart of the park'.

LT to write to Grant Moir, Chief Executive of CNPA expressing concerns

9. BOG Standard Update

JW and JM updated the council on the current state of play with The BOG Standard.

JW said that the team were concerned by the lack of contributions of articles from the 'pillars of the community' such as the church and the community council.

She said that the latest edition, at the printers at the time of meeting, would be the smallest edition to date, due to lack of contributions.

JW said this led the BOG Standard team to question whether or not the village valued the newsletter.

There was agreement from community council members that the publication is valued and there is an interest in it from the residents of the village.

JM wondered if there may be feedback on how the village values the newsletter via the present Community Action Plan consultation. Community council members agreed that they could highlight this on their forms.

After discussion it was agreed that there should be a summer issue in 2025.

10. AOCB

10a. National Speed Management Review

DW spoke of his concerns about The Scottish Government National Speed Management Review to examine the potential effects of changes to speed limits across Scotland. The consultation can be found online at National Speed Management Review - Scottish Government consultations - Citizen Space

This consultation invites feedback on proposals to lower the national speed limit on single carriageway roads from 60 to 50 mph and to increase speed limits for goods vehicles exceeding 7.5 tonnes on single carriageways from 40 to 50 mph and dual carriageways from 50 to 60 mph.

DW expressed concerns about the effects that these proposals could have and asked that all consider responding.

MC confirmed that The Highland Council have submitted a response.
