7a. Short Term Let

It was reported to BoGCC that a property, presently advertising short term lets online, had recently been refused planning permission for such activity.

Advice was sought from MC, who contacted HC Planning. Their response was that this property is still within the appeal period and that HC would wait until any period for appeal has lapsed before taking any form of action. If an appeal is submitted HC would then have to await the outcome of that.

HC also informed us that the property will presumably be due to renew their license soon. Obtaining planning permission is a prerequisite for the license and operating without a license would be an offence.
